I am directed to refer to Jammu & Kashmir Circle' letters No. ED/8-297/2022-23 dated 20.10.2023 & 19.02.2024, on the above-mentioned subject, and to convey the approval of the Competent Authority for creation of a new Kargil Sub-Division under Ladakh Postal Division subject to the following conditions:

- a. Circle shall ensure that there is sufficient increase in revenue generation to cover the overall expenditure. Further, Circle shall evaluate financial performance of the sub-division upon completion of one year. The financial review, along with ECR of Ladakh Postal Division (including revenue & expenditure data of one year, before and after creation of the new subdivision), duly concurred by CIFA shall be submitted to the Directorate for onward submission to IFW.
- b. The expenditure involved in creation of sub-division may be kept to the minimum. No additional funds will be allocated to the circle in this regard.
- c. Redeployment of group 'B' & 'C' posts shall be done with the approval of HoC in consultation with CIFA, as per extant rules. Circle need to ensure that diversion of posts is not affecting the smooth working of present establishments. Further, it may be ensured that these posts had neither been surrendered earlier/recommended for abolition by any work study team/ cadre review committee nor had been placed in "deemed abolished" category as per the instructions of Deptt. of Expenditure (DoE).
- d. Circle may also ensure that sufficient space, as per SoA, is available for the new sub-divisional office and Kargil Sub Post Office within the departmental building.

2. In view of the above, the Circle is requested to take further necessary action in the matter and furnish an Action Taken Report (ATN) to this office at the earliest.

This sanction issues with the approval of competent authority. The advice

of Integrated Finance Wing was conveyed vide their **Dy. no. 56**/ 2024-25/FA-CS(P) dated 05.07.2024.
